**Directions:** From I-540 Bentonville Exit #86. Take Hwy 102/62 East. Continue East on Hwy 62. Route for cars and small horse trailers: Continue on Hwy 62 towards the Rogers Airport, the Equestrian Center will be on the right. Take the access road across the railroad tracks. Turn Right onto N. Arkansas St. Recommended route due to a tight turn for large horse trailers: At the intersection of Hwy 62 and 2<sup>nd</sup> St. Turn Right on 2<sup>nd</sup> Street. - Prix Caprilli Test 2 (Walk, Trot, Canter- Fences will be crossrails, not to exceed 2'-0") Min. 3 riders required
- Dressage Suitability (Group Class – horse never shown above first level) Horses are judged on their suitability for dressage. The judge will make comments about the horse's strengths and weaknesses.
- Dressage Equitation (Group Class – rider never shown above first level) The rider is judged on their position and effectiveness of the aids.
- Walk, Intro, Training 1 tests will be ridden in a small arena, all other tests will be ridden in a standard size dressage arena.
